VICAR'S REPORT – Bill Fulton

Special Meeting on Sunday, February 19

I want to thank you for attending the special meeting of the BC on Sunday, February 19. I think we made an honest assessment of the difficulties associated with our proposed move to the rental house on the new property, and we made a good decision to remain in our current facility. It's difficult to change course once a decision has been made, but sometimes it's necessary.

Meeting with New Fellowship Church

Charles Smith, John Stockwell, David Sorrell and I met with the leadership of New Fellowship Church on March 2 and went over the details of our rental agreement with them. The biggest change is that they're asking us to pay \$1,200 a month in rent, \$200 more than we had anticipated. I've listed all the changes in a separate document that I'll send you.

New Worship Times of 7:30 am and 9:00 am

As we planned, On Sunday, March 1, I announced to the congregation the changes in worship times. I was pleasantly surprised with the positive reactions I got. People said, "We can make this work." I also sent an email to the congregation and asked Linda to send a paper letter by snail mail to those who have no email.

How to shorten the 9:00 Eucharist

I want to make sure we end the 9:00 Eucharist in time for New Fellowship to start at 10:30. Often the 10:00 Eucharist ends at 11:15 or 11:20. I think we need to shoot for a service that goes about an hour and five minutes. At our meeting, let's discuss how we might accomplish that.

Reschedule April BC Meeting

Gail reminded me that our next meeting falls on April 13, Maundy Thursday, when we have a Eucharist scheduled. I suggest we move the meeting to the next Thursday, April 20.

Scholarship request for Christina Escue

Two people wrote to Bishop Rickel with their concerns and he replied to each of them extensively, copying me with his replies.

BISHOP'S WARDEN – Charles Smith

Transition - This particular goal is shaping up to be one of my theme's, probably for the entire year. I have been welcomed back to the re-constituted transition sub-committee of the building committee. Preparations have been made for the first round changes in our building usage (see Building Committee report). I also was invited to a meeting with New Fellowship Church where we discussed lease agreements (see Vicar's report) and what changes need to be made when the lease takes effect (April 1) and what changes can already be anticipated but don't need to happen this month. This gradual change is

a blessing, we can focus on a few things at a time, and a challenge, we will be constantly in transition and we know how much people don't like change.

Speaking of change - be sure to update your Daytimer / calendar / wherever you keep your appointments to note the new service times that were announced last Sunday. They (7:30 AM and 9:00 AM) take effect April 1. This month (March) the BC will meet in the parish hall; next month we will migrate to the modular.

Bibles - Last year the faith formation commission had a discernment group regarding how we envision Sunday school. Most of this year, 2017, will be the same as we have seen in previous years. The differences are: the older class is linking their program with Rite 13 this school year, and next school year (fall of 2017) we will transition to Godly Play as the curriculum for the younger grades. The teacher for our older class mentioned the Bible work they are doing and challenged the discernment group to select a Bible to be given to each person in the older class / Rite 13 program so they could study, make notes, and generally make it their own. A Bible was selected and a case (12) of Bibles has been ordered. During the BC meeting we will be circulating a thank you note for all of us to sign.

Lord's Neighborhood Diner (LND) - St. Antony's has been involved with LND for many years now. Of all the programs our Outreach commission supports, this is the one that qualifies for support from the Marilyn Brandenburg fund in our Diocesan Investment Fund (DIF). The financial aspect of this support will need consideration by the BC.

The final version of January's report and the preliminary version of February's report are complete. Giving slowed down a little more than expected after our fast start, so we lost a little more than expected on the month (-\$2,901.22), but are still well in the black YTD (+\$7,857.18).

I have also revised the budget given the changes in rent and reduction in utilities with New Fellowship taking those responsibilities over next month. It shows us being in the red at year's end, but by \$900 less than previously expected.

Architect and Design Committee

As of Monday Feb. 27 I was notified that the Washington State Department of Ecology has accepted and approved our environmental report for the remediation work completed at the new site. On March 1 I received confirmation that the Site Development Activity Permit-SDAP has been approved by the DCD. Several bonding requirements are necessary to actually receive the SDAP permit. MAP Ltd. has sent the required Right of Way easement for Storm Water Control to the diocesan office for their signatures and notary. A meeting is scheduled for March 15, 2017 with Mr. Jeff Rowe-Deputy Director of DCD. The purpose of this meeting is to resolve the occupancy load calculation conflict that has been put forward by DCD against the 250 head count occupancy designated in the CUP and all noted documents provided to DCD by Rice Fergus Miller and MAP Ltd.

Capital Campaign Committee

The generous people of St. Antony's continue their pledges toward the new church building. At this time, 75% of the \$462,227.00 pledged money is in hand.

The congregation will surely begin to notice that activity is beginning toward moving to the new facility.

- Lay Eucharistic Visitors: There have been more requests for Eucharist visits this month. Hopefully church members are more familiar with this ministry and comfortable with requesting a visit. Father Bill is looking into purchase of a third Eucharist kit to allow for greater ease of multiple visits.
