Delay in building schedule

Our contractor is unable to give us a building schedule because his subcontractors are so busy they can't commit to any time frame. I emailed the Bishop to postpone the consecration date indefinitely. I know everyone is frustrated by the delays but they are simply beyond our control.

Moving offices

New Fellowship Church would like to have the Secretary's Office emptied so they can re-carpet it and move their office in. I have moved the necessities for my office to the modular and we will move Linda's office to the basement tomorrow.

Termination of nursery care worker

After consultation with those involved with the nursery, we had to let one of our workers go. I called her and gave the reasons for our decision and followed up with an email. She missed many Sundays, often without notifying us, she was often late, and she made no effort to take the Safeguarding God's Children training. We have volunteers filling in for the time being, and we'll hire another person later this summer.

Use of space in new building

The large gathering room in the new building will have a number of claims for its use, including the choir, Godly Play, library, and meeting room. We'll have a presentation by the Godly Play team at our meeting about the use of the room because they will need space for their classroom.

Altar and furnishings for new church

The Memorial Committee increased the recommended amount from \$6,000 to \$7,000 to spend for the new altar and furnishings because the estimate for the metal work came in much higher than expected. I'd like a motion to approve this expenditure.

Barn cleaned

My thanks to Jackie Vincent for cleaning up the barn and taking a huge load of garbage to the dump.

New renters

Thanks to the work of David Sorrell and many others, we have renters as of July 1.

Piano

We have signed a contract to purchase the piano from Portland Piano Company and they have the piano in storage for us.

Dear Members and Friends of St. Antony's,

I send you greetings from the New Facilities Committee. The excitement of the new building grows with each day's work. The completed roof and the start of the placement of the siding really add a reality to the project moving toward completion. As a congregation we have observed the completion date be adjusted. This has caused rescheduling of important happenings for the opening service and Consecration of the new building. Again, we are faced with a challenge not brought of by permits, inspections or framing. The whole issue comes down to availability of products to complete specific installations in the building. Associated with that issue is the availability of the craft workers to complete those tasks. Kitsap County construction is so busy currently that the workers are spread thinly across many projects. Materials are not readily available. Our Contractor is waiting for doors to be delivered so that the siding may be completed. Also waiting for the large window for the east side of the building (altar area) and two windows that install over by the church office area. Just recently the fire sprinkler company began the installation, but they only had one person to provide to the job. The electrical work has not started due to availability of electricians. As you can see this has caused significant delays to our project. At this point in time there is no firm completion date. But I can assure you that our contractor and his workers are doing their best to stay busy. They have moved their efforts to work on the Event Shelter. If you have visited the property lately the progress is very evident.

I will do my best to keep you informed of progress and when we may expect to have occupancy.

STEWARDSHIP AND FINANCE – Jim Foley

At the midpoint of the year, we are in the black by \$3,619.52, when we were budgeted to be in the red by (\$5,831.08). This despite a poor showing in June, with income about \$2,000 below budget at \$12,099.77 and expenses about \$1,000 below budget at \$20,988.91. We were

budgeted to be in the red in June, but wound up \$1,000 further in the red for the month, due in large part to the expense of \$3,500 to replace the chairs for New Fellowship as agreed in the sale.

We received the check from the DIF Building Fund for \$697,894.17, of which just over \$500,000 remains after paying the July bill from the contractor. I requested \$47,662 in funds be withdrawn from the Memorial Fund, to cover all the various projects approved in prior meetings.
