### Reopening

I think the emergence of the Delta variant of Covid-19 has made us all aware that we need to continue with social distancing and masks for worship.

#### **Letter of Separation**

#### New computer for Secretary

### **Fire Marshall inspection**

I called Bird Electric and Fox Fire Prevention and scheduled inspections from them. When they're complete, I will file them with the Fire Marshall to bring us in compliance. I set up a free password account on Lastpass.com. This secure site keeps track of all your passwords and other important information. I listed all the accounts that Linda and I use so that the interim vicar will have them available. I also set up a Gmail account named <u>vicarstantony@gmail.com</u>, with a Google Drive account associated with it. I will leave all the files on the vicar's laptop on this Google Drive for the interim vicar to use if desired.

If we accept him, then I contact Arienne, and she will forward a contract. During the interview, Bill Fulton has agreed to leave the meeting for the interview and our deliberations.

Bill Fulton and I met to finalize the Letter of Separation. The BC will need to accept the letter and signatures will be required of Bill, Jim Foley, and me. The letter will then be sent to Arienne for a signature by Bishop Rickels.

John Stockwell forwarded a JPG of the interior of our church, and I incorporated it into the Building Use Policy with modifications to locations of the Chapel Altar, Piano, and Organ as we currently have them.

An additional \$200 from Outreach funds was allocated to purchase two gift cards for the Kinship family we are supporting through Kitsap Regional Resources (for August and September).

On 29 August, our next Outreach Sunday guest speaker will be Kristi Chapman from Mission to Seafarers.

Maggie Scott and Dee Perriera are planning congregation involvement to provide ditty bags for this organization.

Faith Episcopal Church in Poulsbo was featured in a recent Diocesan newsletter regarding their coordinated outreach efforts with Fishline and another local church to provide for the local homeless. Maggie Scott will invite someone from Faith Church to speak to the Outreach Team regarding this ministry.
