## Bishop's Warden – Loretta McGinley

Many thanks to our People's Warden, Holly, for filling in for me while I was unexpectedly away on Grandma duty this month.

Outcome of Zoom meeting on 4/26/23 with Diocesan legal advisor, Judy Andrews, to gather information regarding St. A's Building Use:

- A priority for the Diocese is to maintain the state property tax exemption.
  - 50 days of the year non-church groups may use church property

- 15 of those days may include use of the building by outside groups or individuals for pecuniary gain

- It's OK to charge rent for use of property by non-profit organizations and other groups, either long-term or one-time event usage.
- Outside groups using the church property do not have to have their own liability insurance; it was recommended talking with the Church Insurance Group to further explore our current coverage.
- It was recommended any group using the property sign a hold harmless/release from liability form.
- The coordinator of a requesting group in which children may be present, needs to attend Safeguarding God's Children program and share information with their group participants.

I spoke to a representative from the Church Insurance Group, and I've outlined information from this talk below.

- In renting/loaning space to outside groups, a landlord-tenant relationship exists.
- Liability is determining who is responsible for an injury to the 3rd party. If a non-church person is injured on the property due to St. A negligence (e.g. defective equipment), St. A's is liable.
- If injury to the property occurs by non-church users, a property claim to Church
- Insurance can be made.
- Liability and/or property damage may be covered by an individual's (non-church member) home insurance.
- The Church Insurance representative sent a copy of their Safety and Insurance Handbook for more detail about what they cover.

We need a few folks willing to continue to explore and recommend Building Use guidance for St. A's.
